7 Updates on company projects:

- a. Basin Management Committee (BMC)
 - i. BMC regular session:
- GSW Announced a PFAS detection at their well(s) located near the GSW office (behind Grocery Outlet).
 This could be from the new program C well or the older, shallower well that is impacted by nitrate.
 They didn't test the two separately, so it's impossible to know which was contributing more at this point.
- GSW also requested approval to remove the deferral for the third Program C well so they could pursue the project. S&T voted to remove the deferral, but only on the condition that doing so did not come with any implied increases to the sustainable yield.
- The County presented their Water Offset Study to the BMC and public. In spite of their effort to share the report, Supervisor Gibson made it clear that the forum was not intended to dissect and change the report. He asked for the purveyors to come up with a single memo documenting our collective comments on the report.

Cal OES sent a BCA Request for Information (RFI) and a Programmatic RFI.

Taylor has been working diligently to address requested changes to application. This has required significant coordination with S&T staff and MNS engineers to obtain proper supporting documentation.

RFIs should be completed 9/12-9/13

Cal OES will decide in December 2023 whether S&T's application will be submitted to FEMA for consideration.

FEMA will announce successful applications in late 2024.

S&T must plan for a 25% cost share of \$409,250 (S&T does not qualify for Prepare California Match)

The subapplication lists S&T cash reserves as the match funding source because a source needed to be identified for the purposes of the application. Taylor plans to secure loan funding prior to a HMGP grant agreement (late 2024).

Right now, this will most likely be a Federal SBA Disaster Assistance Loan.

Loans

Taylor will begin application for Disaster Loan Assistance following HMGP RFI submittals, provided she has remaining hours to do so.

S&T is not an eligible applicant for California Infrastructure Bank SRF Loans

DWSRF funding will take too long to obtain before HMGP grant agreement
